Presentation on the LUC Project (water loss, use, and conservation) Consolidated Reporting Database

John Sutton of the Texas Water Development Board provided an overview of the Consolidated Reporting Database. The project is on a timeline going with the annual water use survey and the annual water loss audit being live in December 2014. The consolidated database will include the annual conservation report by May 2015 and will include reports and public access in August 2015.

Presentation on the Texas Municipal Water Consortium

Brewster McCracken of the Texas Municipal Water Consortium presented on the work the group is doing with the University of Texas. The consortium conducts research trials of water supply, management and conservation solutions in homes and businesses across Texas. Mr. McCracken led a discussion after the presentation focusing on membership and the technology the group was advancing.

Discussion on and Action on Content for the 2014 WCAC Legislative Report

CE Williams, chair, opened the floor to walk through the report, section by section.

The Council made minor edits to several portions of the report and requested several sections be rewritten or expanded.

TWDB support staff will work to incorporate the content from Council members, organize the draft, and complete the appendices.

Robert Mace will work with Texas Water Development Board management to find direction on the Council's want to make recommendations in the 2014 Legislative Report. Feedback will be distributed to the Council.
